IN THE MATTER OF the *Pension Benefits Act*, R.S.O. 1990, c. P.8, as amended (the “Act”), in particular sections 83 and 89;

AND IN THE MATTER OF the Retirement Plan for Employees of Carillion Canada Inc., Registration Number 0350801 (the “Plan”).

ORDER

On September 18th, 2020, pursuant to section 83 of the Act, and by delegated authority from the Chief Executive Officer of the Financial Services Regulatory Authority of Ontario (the “Chief Executive Officer”), the Director, Relationship Management and Special Pension Services, issued a Notice of Intended Decision to make an order under section 83 of the Act, declaring that the Pension Benefits Guarantee Fund applies to the Plan.

The Notice of Intended Decision was served on the Plan administrator, Mercer (Canada) Limited, and the employer, Carillion Canada Inc. on September 30, 2020. Section 89(6) of the Act provides that any person on whom a Notice of Intended Decision is served has thirty (30) days after the Notice of Intended Decision is given to request a hearing by the Financial Services Tribunal (the “Tribunal”).

On November 17, 2020 the Registrar of the Tribunal confirmed that the persons on whom the Notice of Intended Decision was served did not request a hearing by the Tribunal in accordance with section 89(6) of the Act. Therefore, pursuant to section 89(7) of the Act, the Head, Relationship Management and Prudential Supervision, makes the following decision.

ORDER

An Order declaring that the Pension Benefits Guarantee Fund applies to the Plan is hereby issued for the reasons set out in the Notice of Intended Decision.
