## **ORDER**

**ON OR ABOUT** July 18, 2011, the Régie des Rentes du Québec (the “Régie”) issued a Decision in respect of the Alcan Pension Plan (Canada), Registration Number 25825 (Québec), (the “Plan”).

**A NOTICE OF APPEAL** was received by the Financial Services Tribunal (the “Tribunal”) on September 1, 2011 pursuant to section 4 of the Agreement Respecting Multi-Jurisdictional Pension Plans in connection with this matter and a hearing in writing was held by the Tribunal.

**THE TRIBUNAL**, in its Reasons for Decision dated May 31, 2012 (the “Decision”), directed the Superintendent to order Rio Tinto Alcan (also known as Alcan Adminco (2000) Inc.) as administrator of the Plan registered in Québec to commence payment to André Provost of the pension to which he is entitled under the Plan, retroactive to November 9, 2009.

**NO APPEAL** has been taken from the Decision under section 91 of the *PBA* by any party and, therefore, the Decision is final.

For the reasons set out in the Decision, **I ORDER** Rio Tinto Alcan (also known as Alcan Adminco (2000) Inc.) to commence payment to André Provost of the pension to which he is entitled under the Plan, retroactive to November 9, 2009.
