If a Request for Hearing (Form 1) is submitted to the Tribunal within thirty (30) days after this Notice of Intended Decision is served on you, subsection 89(8) and 89(9) of the PBA provide that the Tribunal shall appoint a time for and hold a hearing, and by order may direct the Superintendent of Financial Services (Superintendent) to make or refrain from making the intended decision indicated in this notice and to take such action as the Tribunal considers the Superintendent ought to take in accordance with the PBA and the regulations, and for such purposes, the Tribunal may substitute its opinion for that of the Superintendent.

IF NO WRITTEN REQUEST FOR A HEARING IS MADE within thirty (30) days after this Notice is served on you, TAKE NOTICE THAT the Superintendent will carry out the ORDER pursuant to section 89(7) of the PBA.

INTEND TO MAKE THE CONSENT effective only after the Applicant satisfies me that any payments pursuant to the Surplus Sharing Agreement to which the members, former members and any other persons are entitled, have been paid, purchased or otherwise provided for.

I INTEND TO CONSENT FOR THE FOLLOWING REASONS:

- 1. Glencore Canada Corporation is the employer and administrator as defined in the Plan (the "Employer").
- 2. The Plan was wound up effective October 1, 2013.
- 3. As indicated in the report provided with the Employer's application for payment of surplus as at October 1, 2013, the surplus in the Plan was estimated at \$923.
- 4. The application discloses that by written agreement among:
 - (a) the Employer;

and

(b) 100% of the former members and other persons who are affected by the wind up and who are entitled to payments under the Plan as of the date of the wind up (which percentage represents a number of former members and other persons entitled to payment under the Plan that the Superintendent considers appropriate in the circumstances);

the surplus in the Plan at the date of payment, after deduction of expenses, is to be distributed:

- (a) 50% to the Employer; and
- (b) 50% to the beneficiaries of the Plan as defined in the Surplus Distribution agreement.
- 5. The Employer has applied, pursuant to section 78 of the *PBA*, for consent of the Superintendent of Financial Services to the payment of 50% of the surplus to be distributed from the Plan, plus adjustments to the actual date of payment.
- 6. The application appears to comply with sections 78, 79(3) and all other applicable requirements under the *PBA* and Regulation 909, R.R.O 1990, as amended.
- 7. Such further and other reasons as may come to my attention.
