NOTICE OF INTENDED DECISION

I INTEND TO MAKE AN ORDER under section 69 of the *PBA* that the **Pension Plan for the Employees of Scythes Inc.**, Registration Number **0302026** (the “Plan”) be wound up effective **April 30, 2014**.
