NOTICE OF INTENDED DECISION

I INTEND TO CONSENT, under section 62.1(5) of the PBA, to the payment from the pension fund for the Plan to Dow Chemical Canada ULC, in the amount of \$7,138,609.64, as at January 31, 2015, plus investment earnings thereon to the date of payment.

If a Request for Hearing (Form 1) is submitted to the Tribunal within thirty (30) days after this Notice of Intended Decision is served on you, subsection 89(8) and 89(9) of the PBA provide that the Tribunal shall appoint a time for and hold a hearing, and by order may direct the Superintendent of Financial Services (Superintendent) to make or refrain from making the intended decision indicated in this notice and to take such action as the Tribunal considers the Superintendent ought to take in accordance with the PBA and the regulations, and for such purposes, the Tribunal may substitute its opinion for that of the Superintendent.

IF NO WRITTEN REQUEST FOR A HEARING IS MADE within thirty (30) days after this Notice is served on you, TAKE NOTICE THAT the Superintendent will carry out the Consent pursuant to section 89(7) of the PBA.

REASONS FOR PROPOSAL:

- 1. Dow Chemical Canada ULC is the employer and administrator as defined in the Plan (the Employer).
- 2. The Plan wound up in part effective July 1, 2007, January 1, 2008, January 1, 2009 and January 1, 2010 and wound up in whole effective June 30, 2010.

- 3. The Plan had a liability under section 75 of the PBA on wind up.
- 4. The Company has been funding the liability under section 75 of the PBA.
- 5. The latest report prepared by an actuary and filed by the Company as Administrator of the Plan under section 32(1) of Regulations 909, R.R.O. 1990, as amended (the Regulations) shows that there is no further amount to be funded. There is money remaining in the pension fund in the amount of \$7,138,609.64.
- 6. In these circumstances, section 32(4) of the Regulation states that the money remaining in the pension fund may be paid to the employer in accordance with section 62.1 of the PBA, as if the money was an overpayment into the pension fund by the Company within the meaning of section 62.1(1)(b) of the PBA.
- 7. Such further and other reasons as may come to my attention.
