NOTICE OF INTENDED DECISION

I INTEND TO MAKE AN ORDER under section 69 of the PBA that the Pension Plan for the Salaried Employees of Grant Forest Products Inc. – Timmins, Registration Number 1053008 (the "Plan") be wound up effective March 31, 2011.

I INTEND TO MAKE THE ORDER FOR THE FOLLOWING REASONS:

To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Intended Decision is served on you.**1**
