I INTEND TO MAKE THE ORDER FOR THE FOLLOWING REASONS:

- 1. The Plan is registered under the PBA.
- 2. The Plan provides defined benefits that are not exempt from the application of the Pension Benefits Guarantee Fund by the PBA or the Regulations made thereunder.
- 3. The Plan was wound up effective May 12, 2009.
- 4. There are reasonable and probable grounds that the funding requirements of the PBA and regulations cannot be satisfied. Based on the latest actuarial certification, there is an estimated claim against the Pension Benefits Guarantee Fund of \$1,048,100.00 as at August 31, 2011. If funds become available from the estate of the employer, the administrator will be required to make an appropriate refund of any allocation amount received by the Plan from the Pension Benefits Guarantee Fund.
- 5. Such further and other reasons as may come to my attention.
