## NOTICE OF PROPOSAL

**I PROPOSE TO MAKE AN ORDER** under section 69 of the *PBA* that the **SKD Company Pension Plan for Hourly Employees of the Milton Division** (the “Plan”) be wound up effective **March 31, 2009 and to include members, former members and others having an entitlement under the Plan during the period January 22, 2009 to March 31, 2009.**

### REASONS:

**There was a cessation or suspension of employer contributions to the pension fund.**

**All or a significant portion of the business carried on by the employer at a specific location was discontinued.**

**Such further and other reasons as may come to my attention.**

**YOU ARE ENTITLED TO A HEARING** by the Financial Services Tribunal (the “Tribunal”) pursuant to section 89(6) of the *PBA*. **To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Proposal is served on you.**<sup>1</sup>
