NOTICE OF PROPOSAL

I PROPOSE TO CONSENT under section 78(4) of the *PBA*, to the payment out of the Plan to **Domtar Inc.**, as at January 23, 2008 in the amount of **\$771,169.49** plus interest to the date of payment.

REASONS:

- 1. Domtar Inc. is the employer as defined in the Plan.
- 2. As a result of the employer funding the deficit on the partial wind up of the plan as at March 31, 2006, there are assets remaining after the partial wind up benefits have been settled.
- 3. Evidence of the overpayment to the fund has been submitted to the Financial Services Commission of Ontario.
- 4. Such further and other reasons as may come to my attention.
