## **NOTICE OF PROPOSAL**

**I PROPOSE TO MAKE AN ORDER** under section 78(4) of the *PBA*, consenting to the  
payment out of the Plan to **The Roman Catholic Episcopal Corporation for the Diocese of  
Sault Ste. Marie**, as at **December 13, 2007** in the amount of **\$216,195** plus interest to the date of  
payment.

### **REASONS:**

1.     **The Roman Catholic Episcopal Corporation for the Diocese of Sault Ste. Marie** is  
the employer as defined in the Plan.
2.     As a result of the employer making contributions to the Plan on the basis of an  
actuarial report for which the effective date had passed, when the new report was  
filed the actual contributions made had exceeded those that would otherwise have  
been required.
3.     Evidence of the overpayment to the fund has been submitted to the Financial Services  
Commission of Ontario.

4. Such further and other reasons as may come to my attention.

**YOU ARE ENTITLED TO A HEARING** by the Financial Services Tribunal (the “Tribunal”) pursuant to section 89(6) of the *PBA*. **To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Proposal is served on you.**<sup>1</sup>
