



Application to Withdraw or Transfer up to 50% of Amount Transferred to a Variable Benefit Account Form VB 2

(Under Section 39.1(5) of the Pension Benefits Act)

Approved pursuant to the *Pension Benefits Act* (R.S.O. 1990, c. P.8)

What you need to know before completing this Form

Use this Application if:

- you established a variable benefit account in the Pension Plan identified in Part B (the "Pension Plan");
 and
- you want to withdraw or transfer up to 50% of the amount transferred to your variable benefit account at the time it was established.

This Application will not be valid if it is received by the administrator more than 60 days after the variable benefit account was established.

Please be aware that when money is withdrawn or transferred from a locked-in variable benefit account to an unlocked account, the money will lose the creditor protection provided by the Pension Benefits Act and Regulations thereunder.

Any withdrawal or transfer from your variable benefit account may have tax consequences. To find out more about any possible tax consequences, contact the Canada Revenue Agency.

If you want to withdraw or transfer up to 50% of the amount transferred to your variable benefit account, please read this document carefully and sign, date and fill in the required information, **in the presence of an adult witness**, and have your witness sign the Application.

Send your completed Application Form to the Plan Administrator.
