NOTICE OF PROPOSAL

I PROPOSE TO MAKE AN ORDER under section 69 of the *PBA* that the **Pension Plan for the Employees of BLP Bronze International Ltd**. (the "Plan") be wound up effective **April 30**, 2007.

REASONS:

There was a cessation or suspension of employer contributions to the pension fund.

The employer failed to make contributions to the pension fund as required by the PBA.
