**NOTICE OF PROPOSAL**

**I PROPOSE TO MAKE AN ORDER** under section 69 of the *PBA* that **Grafikom Limited Partnership Pension Plan** (the "Plan") be wound up effective **November 10, 2008**.

**REASONS:**

There was a cessation or suspension of employer contributions to the pension fund.

The employer failed to make contributions to the pension fund as required by the *PBA*.

The employer is bankrupt within the meaning of the *Bankruptcy Act*.

Such further and other reasons as may come to my attention.

**YOU ARE ENTITLED TO A HEARING** by the Financial Services Tribunal (the "Tribunal") pursuant to section 89(6) of the *PBA*. **To request a hearing, you must deliver to the Tribunal a written notice that you require a hearing, within thirty (30) days after this Notice of Proposal is served on you.\***
