IN THE MATTER OF the *Pension Benefits Act*, R.S.O. 1990, c. P.8, as amended (the “Act”), in particular subsection 68(6) and section 89;

AND IN THE MATTER OF the Pension Plan for the Employees of Summit Food Service Distributors Inc., Registration Number 1079425 (“Plan”).

ORDER

On November 3, 2023, pursuant to section 89(2) of the Act, and by delegated authority from the Chief Executive Officer of the Financial Services Regulatory Authority of Ontario (the “Chief Executive Officer”), the Head, Pension Plan Operations and Regulatory Effectiveness (the “Head”) issued a Notice of Intended Decision to make an Order under subsection 68(6) of the Act to require Colabor Group Inc. to change the effective date of the wind up of the Plan.

The Notice of Intended Decision was delivered to Colabor Group Inc. on November 3, 2023, and section 89(6) of the Act provides that any person on whom a Notice of Intended Decision is delivered has thirty (30) days after the Notice of Intended Decision is received to request a hearing by the Financial Services Tribunal (the “Tribunal”).

On November 13, 2023, Colabor Group Inc. wrote to the Tribunal and waived its right to a hearing by the Tribunal under subsections 89(6) and 89(8) of the Act. Therefore, pursuant to section 89(7) of the Act, the Head makes the following order.

ORDER

The effective date of the wind up of the Pension Plan for the Employees of Summit Food Service Distributors Inc., Registration Number 1079425 shall be changed to March 1, 2017.
