IN THE MATTER OF the *Pension Benefits Act*, R.S.O. 1990, c. P.8 (the “PBA”), in particular sections 69 and 89;

AND IN THE MATTER OF the **Pension Plan for the Employees of TLC Vision (Canada) Corporation**, Registration Number **1143056** (the “Plan”).

ORDER

On September 29, 2023, pursuant to section 89 of the PBA, and by delegated authority from the Chief Executive Officer of the Financial Services Regulatory Authority of Ontario (the “Chief Executive Officer”), the Director, PBGF Management (the “Director”) issued a Notice of Intended Decision to make an order to wind up the Plan effective August 7, 2020 under section 69 of the PBA.


The Notice of Intended Decision was delivered to the administrator and the Farber Group, the Trustee in Bankruptcy on August 10, 2023. Section 89 of the PBA provides that any person on whom a Notice of Intended Decision is served has thirty (30) days after the Notice of Intended Decision is served to request a hearing by the Financial Services Tribunal (the “Tribunal”).

On November 20, 2023, the Registrar of the Tribunal confirmed that the persons on whom the Notice of Intended Decision was served did not request a hearing by the Tribunal in accordance with section 89 of the PBA. Therefore, pursuant to section 69 of the PBA, the Director makes the following decision.

ORDER

An Order to wind up the Plan is hereby issued effective August 7, 2020 for the reasons set out in the Notice of Intended Decision.
