Revised Certificate of Automobile Insurance Form and Data Elements

To the attention of all insurance companies licensed to transact automobile insurance in **Ontario**

This bulletin outlines new requirements in the Certificate of Automobile Insurance (Ontario) form, also known as the Declaration Page, for use with the Ontario Automobile Policy form ⊟Owner's Policy (OAP 1). The new requirements reflect Ontario government reforms to auto insurance as announced in Property & Casualty Auto Bulletin No. A-06/15, dated August 31, 2015.

The new Certificate of Automobile Insurance (Ontario) must be used for all policies issued or renewed on or after June 1, 2016, the effective date of the reforms.

A sample of the new Certificate of Automobile Insurance (Ontario) is attached. The Explanatory Notes on Data Elements for the Revised Certificate of Automobile Insurance and Data Elements for Certificate of Automobile Insurance reference documents are also attached.

Filing Certificate with FSCO

Insurers using the sample Certificate of Automobile Insurance (Ontario) must prepare certificates in accordance with the Forms Filing Guidelines and file using ARCTICS with the Financial Services Commission of Ontario (FSCO) by December 15, 2015:

The blank copy and sample certificates should include company logos.

forms that are no longer up-todate or accurate. Readers should visit the **forms** section of the FSCO website, to ensure they are using the most recent version of a FSCO form.

Insurers that wish to use custom-designed certificates must obtain prior approval from FSCO as required under section 232 (5) of the Insurance Act.

Designs must meet the requirements outlined in the Data Elements for Certificate of Automobile Insurance (attached), and insurers must also submit their custom-designed certificates for approval by December 15, 2015.

Consumer Disclosure Addition in 2016

FSCO is forming a Reform Information Working Group (Group), comprised of FSCO staff and representatives of the insurance industry to develop a point-of-sale disclosure document intended to inform consumers of their new coverage choices as of June 1, 2016. Insurers will be required to include the document with new business and policy renewals effective on or after June 1, 2016.

Once the Group has finalized the disclosure document, FSCO will issue an amended Certificate of Automobile Insurance (Ontario) that will introduce the text of the document as an additional data element of the certificate.

Insurers will not be required to re-file certificates that are amended for the sole purpose of reflecting the inclusion of the disclosure document.
