Every employer who establishes an employment pension plan that is subject to the Pension Benefits Act (PBA) must submit the pension plan to FSCO for registration. Employment pension plans provide an important source of retirement income for employees and their families. The mandate of FSCO's Pension Division is to administer and enforce the PBA and Regulations to protect the rights and benefits of pension plan members and regulate pension plans in a fair, effective, efficient and responsive manner.
