## Rule #2 - Mandatory Electronic Filings Rule

### Insurance (Auto) Sector

**Posting Date:** February 15, 2011  
**Effective Date:** February 15, 2011

The following filings must be made electronically in accordance with the Instructions issued and updated by the Superintendent from time to time:

1. Rates and risk classification systems required to be filed under section 7 of the Automobile Insurance Rate Stabilization Act, 2003, S.O. 2003, c. 9 or under section 413 of the Insurance Act, R.S.O. 1990, c. I.8.
2. Rates and risk classification systems required to be filed by the Facility Association, other than in respect of the Personal Vehicles – Private Passenger Automobile category of automobile insurance, under section 410 of the Insurance Act, R.S.O. 1990, c. I.8.
3. Underwriting rules required to be filed under section 238 of the Insurance Act, R.S.O. 1990, c. I.8.
4. Rates relating to endorsements required to be filed under section 413 of the Insurance Act, R.S.O. 1990, c. I.8.
5. Underwriting rules relating to endorsements required to be filed under section 238 of the Insurance Act, R.S.O. 1990, c. I.8.
6. Forms required to be filed under section 227(1) of the Insurance Act, R.S.O. 1990, c. I.8 and certificates of automobile insurance required to be filed under section 232 (5) of the Insurance Act, R.S.O. 1990, c. I.8.
7. Rate manuals associated with the above filings.
